Matters Arising	Highways – Highways Dept have painted SLOW on the Graig Hill road and near Ralph Carpenter's house. More road signage to be placed near St Celynin's Church in November CS – It is reported that speed bumps and a chicane are to be placed in Bronwydd; need to discuss. Residents of Clifford House stated that the white line painting was done at 2.00 am!  IJ – The County Council delivered but then withdrew a dog mess bin because there was an existing one.  CS – Nantgwyn Public Footpath; Brinley Jones has requested that the footpath be re-routed around the farmyard.  CS – The Vicarage; only one dwelling to be constructed not two. There was no mention of the prerequisite of laying a new entrance and pavement before commencement of building in Planning Permission.  ED – Clerk has delivered a cheque donated by Sion Erian, son of the late Jenny Eirian Davies, as a contribution from the Fund, to the School.  Clerk has yet to confirm ownership of the area of wilderness near Penbontbren  A Public Meeting to be held early in September, following the Community Council meeting, to allow the community an opportunity to comment upon the Traffic Management Plan.	
Correspond ence	Safe Routes for Communities – matter to be noted in Minutes so that sufficient preparation time is available to apply next year. IJ believed that presence of School strengthened case. CS said that the Safe Routes matter needed to be raised in the Public Meeting and that a date for the Public Meeting to be decided asap for inclusion in VV. IJ suggested that a letter be sent to Mathew Howells requesting

AOB	AN – Arwyn Thomas has discovered information on perhaps 3 other soldiers from the Parish who perished in the 1 <sup>st</sup> World War, perhaps other names will be released by the War Office. Clerk was to have placed item on the Agenda IJ had found another four previously unmentioned soldier from the Bronwydd area.  Would the Community Council be willing to fund/part fund a Memorial Plaque for 2 maybe 3 soldiers? A Plaque would cost around £700. DD suggested deferring the decision. AN proposed erecting a Plaque for 2 or 3 soldiers. PJ suggested that the Plaque would be for the benefit of the whole community therefore the Community Council should at least contribute towards the cost. ED proposed erecting a commemoration for the 3 soldiers. An unanimous decision was made in favour of commemorating the 3 soldiers and to cover all of the expenses.  PJ – a complaint received about slow Broadband speed. BTs response was that cables from the Exchange needed upgrading. CS said that BT were in the process of doing the upgrade and that the work would be completed by the end of September. IJ mentioned that new telegraph poles were being erected in Bronwydd, a sign perhaps that a better service was on the way! CS suggested that an enquiry be made of BT regarding the number of homes that would benefit from the upgraded service.  ED – Celynos had benefitted from drainage work done on the road in front of their property; what procedure had they followed? The Community Council Clerk is repeatedly writing letters to the County Council requesting that repair and maintenance work be done, how was this work done so swiftly?  CS – Requested a date for the Public Meeting for inclusion in next edition of VV.  DJ – Nebo Square – would the Council be willing to lay some tarmac if there was a wall?  DD – crumbling stonework on the bridge parapet, Clerk to contact Tony Williams and copy message to IJ.
