Matters Arising	Traffic Improvement Plan – AN, DL and Clerk had met with J McEvoy and discussed constructing a chicane on the road opposite the small entrance to the Playing Field, moving the Play Area sign from in front of the new Vicarage to the opposite side of the road, Driver Feedback Sign on the approach to the School and improvements to the junction at the bottom of Coopers Hill. It was stated that Traffic Data Counters would be lain by the School, Hall and Pant-teg. It was suggested that a Driver Feedback Sign should be erected near the Playing Field although EE was of the opinion that motorists ignored them; ED agreed. AN & EE stated that some traffic calming measures needed to be done, e.g. laying speed bumps outside the School? There was agreement that Traffic Data Counters were ineffective as deterrents but at least they were evidence of Council intent. ED suggested that it would be better to decide on what to do and share the plans with J McEvoy before he decided what action to take. A timetable of improvements is necessary. Perhaps prioritising the Playing Field would be better although both Play Area and School are at risk at both sites stated DL .
