Minutes	The number of patients associated with the closing Llandysul Doctors Surgery was incorrect; there were approx. 7,000 patients to be transferred and some 400 were to be transferred to Furnace House.	
Precept	<p>Setting the 2019 Precept – The Precept has not been raised in years and if it were to be increased, the additional funds were not to be spent on work that was the responsibility of the County Council. With additional Precept monies, local organisations such as the Memorial Hall, Playing Field and good causes could receive additional funds. The village assets were for the benefit of the whole community although in reality there were only used by a small number and consequently, the revenues received by both were low. By increasing the Precept and therefore the contributions to the community assets, the whole community would be supporting them.</p> <p>During the Precept discussions, ED once again stated that if the County Council did not undertake more of their responsibilities, there was very little purpose for regular Community Council meetings. When the same issues were being discussed meeting after meeting, this was a complete waste of Community Council time and finances. DD proposed that the Community Council meet every 3 months unless there was a more positive response from Local Government.</p> <p>It was agreed to raise the Precept by £3.00/ann. to £25.00.</p>
