Update from Carmarthenshire County Council	County Cllr Davies was able to report the following: Several strongly worded emails have been sent to the Highways department and the Chief Executive regarding the crash barriers (or lack thereof) between Panteg and Bronallt. Photographic evidence was also sent and an explanation required as to their scoring system that would lead to such a delay in repairing these barriers. It was noted some tape had been put up in the area but it could not be confirmed by whom. The matter of replacement village signs is ongoing. The explanation from Carmarthenshire CC was there have been problems with the contractors. It was noted that advertisements are being attached to the finger signposts in the village. This was advised as illegal. The signs remain the property of Carmarthenshire CC who take a dim view of such an activity. The traffic calming request between the village hall and the park is progressing. A site visit is to be arranged to assess exactly what is needed and what can be done. All issues regarding Skanda Vale are now solely in the hands of Carmarthenshire CC and LLCC await their response. The hedge and verge trimming was praised for its timeliness and quality this year.
